**Montessori****Pricing Supplement (from September 2025)*****for 9 months to 3 year olds claiming Extended Entitlement (up to 30 hours per week)***

Beginning in September 2025, eligible working parents of children aged 9 months to two years old will now be able to access up to 30 hours of free childcare per week. This expansion builds on the existing provision for older children and is designed to support families by making early education and childcare more accessible during these crucial early years.

To qualify for this extended entitlement, both parents (or the sole parent in a single-parent household) must be working and earning at least the equivalent of 16 hours per week at the National Minimum Wage or National Living Wage. Additionally, neither parent should have an adjusted net income exceeding £100,000 per year. The free entitlement provision is to be applied for 38 weeks per year up to a maximum of 30 free hours per week. All hours of the day, 5 days a week, are eligible to be provided free of charge under the free entitlement provision with the exception of 10am to 11am every day. Therefore, a child attending for 4 or 5 full days (8am – 6pm) will be able to claim the full 30 hours free entitlement per week. A child attending 3 full days (8am – 6pm) will be able to claim 27 (9 x 3) hours free entitlement per week. A child attending for 5 half days (8am – 1pm) will be able to claim 20 (4 x 5) hours free entitlement per week, and so on. Additional hours will be charged at the rates shown in the below tables. Furthermore, the free entitlement covers basic teaching provisions; however, it does not cover the cost of extras such as meals & snack and we thus charge for this separately. Please note that you are not obligated to take these extras as a condition to receive the free entitlement.

The invoices are broken down as follows:

1. Free entitlement per week for 38 weeks per year
2. Additional chargeable hours per week for 38 weeks per year
3. Meals & Snacks per week for 38 weeks per year
4. Full nursery fees for 10 remaining weeks per year

The total fees for the year are calculated as above, and then divided by 48 weeks to give a weekly cost (net of the free entitlement). This effective weekly rate is multiplied by 4.4 to give the monthly cost for all months except August and December. For August and December, the monthly cost is calculated by multiplying the weekly fees by 2. Thus, over the course of the year, the full annual fee (net of the free entitlement) is paid over the course of the 12 months.

For parents seeking to utilize only government-funded hours, we would like to highlight that the session from 1:00 PM to 6:00 PM is the only time slot eligible to be fully covered by government funding, subject to availability. Please note that for these fully-funded sessions, additional services and extras such as school provided snacks, tea-time, music & language classes, and school outings may not be included.

Please note that these rates are valid for under 3y olds and a new pricing supplement will be applicable for the school term following your child's 3<sup>rd</sup> birthday. Please refer to the over 3y olds supplement if you would like to plan for future fees. You will find that these rates are higher than for under 3y olds. As children grow and move into the over-three age group, we strive to provide them with a richer, more diverse range of activities and experiences. This includes special offerings like French lessons and local outings, all designed to enrich their learning experience. Because of these additional opportunities, the hourly rate for over-three-year-olds is slightly higher, reflecting the added value and experiences we provide to support their development.
